

## KingGee Scratch to Win Competition 2019

### TERMS & CONDITIONS OF ENTRY – COMPLETE VERSION

1. These terms and conditions, including information on how to enter, and a description of the prize that may be won in the Promotion, apply to the "KingGee Scratch to Win" competition.
2. Entry is open to customers who purchase any KingGee branded apparel/garment to the value of \$100.00AUD or higher who are over the age of 18 and are residents of Australia ("Eligible Entrant").
3. Employees and their immediate families living in the same household as the employee of the Workwear Group and its related entities, printers, suppliers, providers and agencies involved in this competition are ineligible to enter.
4. Definitions within these Terms and Conditions:
  - (a) Eligible Entrant - any customer who purchase any KingGee branded items to the value of \$100.00AUD or higher who are over the age of 18 and are residents of Australia
  - (b) Promotional Period - 07.00am AEDT Monday 7<sup>th</sup> January 2019 to 11:59pm AEDT Sunday 3<sup>rd</sup> February 2019
  - (c) Promoter – Workwear Group trading as KingGee (ABN 82 004 055 387, Level 1, 187 Todd Rd, Port Melbourne, Victoria 3207)
  - (d) Qualifying Purchase – any KingGee branded or labeled item (including apparel and accessories)
5. This Promotion (the "Promotion") runs 07.00am AEDT Monday 7<sup>th</sup> January 2019 to 11:59pm AEDT Sunday 3<sup>rd</sup> February 2019
6. To enter, an Eligible Entrant must make a Qualifying Purchase at a Totally Workwear Store and pay in full at time of purchase ("Eligible Purchase"). Customer must spend \$100.00 AUD or more in a single transaction during the promotional period to receive a scratch card. Customer scratches their scratch card in-store for their instant win prize. The prize will be awarded to the customer instantly, once they provide the original winning scratch card which indicates their winning prize. The prize must be redeemed from the store the purchase was made only. Eligible Entrants can receive one (1) entry per calendar day irrespective of all the Eligible Purchases made on that day.
